#### **Round of Introductions** for guests

Nelli Williams, Trout Unlimited, Alaska Program Director Steve Cohn – The Nature Conservancy, Alaska Chapter Director

#### **Partnership Business**

- Partnership fiscal agent change
  - Update on transition and new potential sponsor Shift from The Nature Conservancy as a fiscal sponsor to Trout Unlimited
  - Letters have been provided by both TNC and TU regarding changes in fiscal sponsorship, contact Jessica if you need them
  - o Transition from TNC to TU will occur in early September 2020
    - Steve Cohn (The Nature Conservancy, State Chapter Director) spoke on the difficult decision to step down as fiscal sponsor as a result of shift in Nature Conservancy direction and downturn in funding. This decision is not a reflection on the effectiveness of the Partnership or Jessica Speed.
    - Nelli Williams (Trout Unlimited, Alaska Program Director) honored to be approached to further support the Partnership as fiscal sponsor
      - TU is involved with Fish Habitat Partnerships from the National Board level, to partnerships across the country and throughout Alaska.
    - There is general understanding and support from the Steering Committee as well as immense gratitude for TNC for their dedication and TU for stepping in.
    - There are some additional details and logistics that need accomplished before everything is finalized.
  - Partnership FY21 funding and budget \*Partnership FY21 Budget (pending)
    - Revenue: Two scenarios are presented, one of which is with a virtual symposium
      - Current revenue forecast looks good for FY21 with help from excess NFHP funds
      - TU hopes to contribute more than 5K
    - Expenses: Coordinator will now be a FTE
      - There are some differences in overhead and benefit costs between TNC and TU fiscal sponsorship

- o 6K wiggle room for general contracts or cushion
- Decision: Does budget receive approval from Steering Committee? Approved
- o Planning for the 2020 Partnership site tour and 2020 Mat-Su Salmon Symposium
  - 2020 Site Tour
    - Was determined to have it virtually
    - Generally hosted in August, and recommended to be pushed to late September or early October to accommodate fiscal sponsorship and planning
    - Ideas Virtual event highlighting the project mapper, launching and discussing new outreach materials
      - Can short videos be included on the project mapper for some of the projects? Ted interested in helping make this happen next summer, MSB can also possibly support with GIS Story Maps
      - Suggested Event Project Mapper & online session with Mike Gracz and info on Wetlands Ordinance (follow up with Outreach Committee regarding timing and event)
      - Maybe include in Symposium
  - 2020 Mat-Su Salmon Symposium
    - Agreed that it will not be an in-person event SC approves virtual
    - A vision for the event has not been created but it would have to be a simplified version – Tentative Nov 18<sup>th</sup> & 19<sup>th</sup> and have general agenda and could be hosted via Zoom (or similar)
    - Someone would need to be hired before Jessica leaves in August to keep symposium moving
    - Questions and concerns about loss of in person networking, technology, duration on a webinar,
    - Thoughts partners to share short videos of their work, expand tidbits section for brief presentations, share good news, simplify with a big evening event and exciting key note
      - o 3 symposium sessions + Keynote Address, Community Corner (share other perspectives)
- o Other Partnership business to consider
  - August 2020 Social Media & Communications while Jessica is away TU is interested in helping
  - Further Social Media Outreach & Communications TU is interested in supporting as well
  - September the RFP for National Fish Habitat Partnership funds will need to be reviewed and approved by the September 8<sup>th</sup> Steering Committee meeting.

  - o NOAA (Erica) No NOAA Updates, Erica will be out on maternity leave starting in August and will return in November/December
  - MSB (Ted) Shared <u>Wetlands Ordinance project page</u> being provided for MSFWC for action in September then will move to MSB Assembly, characterized as a more conservative ordinance
  - o GLT (Libby) Recently helped open a new trail Swan Lake Trail in the Palmer Hay Flats, paired with a virtual event that was well received
    - Wrapped up a project conserving lands on the Kenai River
  - TU (Eric) successful virtual premiere for Eklutna Film, film will be released to the public in September 2020
    - Continued involvement in Eklutna mitigation process as a stakeholder
    - Fiscal Sponsorship transition!
  - o USFWS (Trent) Ongoing projects, in the process of new hires
  - o TTCD (Christy) Pike suppression activity continuing in a limited way
    - Applied pesticides (elodea or pike?)
    - Shared a video "The Great Pandemic Salmon Release" to share releasing salmon in the classroom fish during COVID
  - o ADF&G (Michael) Working on getting 2020 cost share projects in the ground
  - TNC (Jessica) There was funding available for Elodea suppression that had to be canceled due to COVID
    - TNC Alaska conservation focus on Bristol Bay, Southeast Alaska and climate change
