- National or statewide updates
 - o ACE act is in the process of being reauthorized
 - NFHP has a project database includes detailed metrics & useful front end user capabilities - like printing out of NFHP funded project summaries. Will be public facing soon.
 - National Fish habitat assessment completed by NFHP (every 5 years) planned for 2025.
- Partner updates
 - ADFG: 2nd year of NFWSF to resurvey & add culverts to the mapper; 1 month into the effort; added new culverts & updated AWC significantly for 2 streams - very productive summer field season.
 - o NOAA: productive site visits with partners & NOAA DC/HQ folks; DOT funding; round 3 funding upcoming in the fall LAST round for BIL/IRA
 - Tyonek: Culvert update LARGEST BIL funded culvert in the State of Alaska;
 video/promo to document progress, story-telling, and promo uses; Knik is doing stream bank restoration; outlook for next year's surveys.
 - o Trout Unlimited: no updates at this time; kudos to the Montana Creek Planting team.

 - O Plants for Salmon Community Planting Day was a great success! It was held on June 15th 10-2pm, Montana Creek at Yoder Rd. bridge, Talkeetna. We had great community turn-out (about 75 people) including local families and kids. Knik Tribe provided plant materials, and added topsoil to a large section of riprap which partners planted and will later this summer receive hydroseeding. This event was planned by a multi-partner committee engaged in restoration of this site (SRC, USFWS, Knik Tribe, ADFG, TU, MSB, Mat-Su Salmon Partnership). Great job everyone!
